Performance in the job is evaluated quarterly. There are specific performance objectives that the successful candidates must achieve by the end of the first year in the job. <p>The accountabilities for the job and typical work activities are as follows:</p> <ul style="list-style-type: none"> ▪ Continually control pipeline/station pressures, set points, and monitor the hydraulic gradient display for optimum performance within established system safety and integrity parameters. ▪ Oversee the operational status of pipeline facilities. Investigate any alarms, events, or change in state of pumps, valves, or related equipment. Respond to abnormal and emergency conditions to insure system integrity. Immediately investigate any leak alarms, deviation alarms, or natural or man-made integrity threats to determine if the potential for a leak exists and take actions as required. ▪ Continually control oil movement on the Valdez Marine Terminal (including operation of Backpressure control, relief facility, scraper receiving and Incoming and Berth metering), pressure and flow for optimum performance within established system safety and integrity parameters. Provide management of VMT tankage through continual control and tracking of tank usage, levels, water draws, and related activities. ▪ Develop vessel schedules in compliance with the Operating Agreement. Distribute accurate vessel schedules on a regular basis. Promote system safety and efficiency by effectively communicating changes in the vessel schedule that may impact operating conditions or equipment status. Notify Alyeska personnel of non-routine operational conditions. Notify producers of abnormal conditions and anticipated high inventories. Help coordinate notifications during abnormal operations.

Pre-Employment Drug Screen Testing:	<ul style="list-style-type: none"> ▪ Alyeska Pipeline Service Company (APSC) requires pre-employment drug testing utilizing hair test collections for all positions. The preferred collection site is from the head (approximately 1/2 inch of hair length necessary). Head hair testing provides an approximate 90 day window of detection that checks for drug use. In addition, for Department of Transportation covered positions, APSC will also utilize urinalysis testing. Any positive drug test makes you ineligible for APSC employment. ▪ It is important to note that APSC does not seek or accept any genetic information as part of the hair testing procedure or any other process that could directly or inadvertently provide genetic information (family medical history).
