Conducts daily supervisory coordination with Projects, Fire and Safety, Environment, Security, Engineering, Maintenance Planning, other groups/departments. Develops and maintains positive relationships and direct interface with regulators, business stakeholders, and internal/external work groups. Accountable for modeling behaviors consistent with Alyeska's code of conduct. This job also requires considerable oversight of Alyeska and contract employees.
